Through partnerships with the Emergency Food Network, local grocers, and community donors, EFA distributes nutritious food to households in need. In 2024, the Food Pantry served approximately 18,400 individuals through 6,300 household visits, distributing more than 438,000 pounds of food. The program ensures that residents have consistent access to fresh produce, dairy, protein, and shelf-stable items, promoting health and stability for vulnerable community members.**4b** (Code:) (Expenses \$ 335,182. including grants of \$) (Revenue \$ 447,615.)Thrift Store (Center Street Junction): Center Street Junction, EFA's nonprofit thrift store, provides affordable clothing, furniture, and household goods to the community while generating essential revenue to support Eatonville Family Agency's food and outreach programs. The store also offers vouchers to individuals and families in crisis, allowing them to obtain needed items at no cost. Due to the high volume of donations received daily from community members, the total number of donated items is not tracked; however, the store serves hundreds of shoppers each week and plays a vital role in meeting basic needs, reducing waste, and sustaining EFA's mission-driven programs.**4c** (Code:) (Expenses \$ 22,590. including grants of \$) (Revenue \$)Outreach and Other Services (including DSHS Outreach): Eatonville Family Agency's Outreach and Other Services program connects individuals and families with essential resources that promote stability and self-sufficiency. Through a partnership with the Washington State Department of Social and Health Services (DSHS), a certified outreach specialist assists clients in applying for public benefits such as SNAP and other supportive programs. In 2024, EFA staff provided direct assistance to clients and shared information widely within the community to ensure that all who need support are aware of and able to access available services.**4d** Other program services (Describe on Schedule O.)
